2. Short description of research interests and activities

(i) Language teaching in secondary education

Investigation of the changes taking place in the last years at the level of secondary school in Greece concerning objectives and contents of language teaching, bilingualism, linguistic variation and language competence, language maintenance and language change

(ii) Theories of educational organizations

Theory development and empirical research on the tendencies present in contemporary educational environments as to its organizational forms and types of control, their effectiveness and the fluctuation of the social value of educational entitlement in the labor market

Empirical research on the ways socially disadvantaged groups are discriminated against at school and development of educational programs for the prevention and fighting of discrimination in educational contexts.

(vi) Teaching History in primary and secondary education

Theory development and empirical research on the development of curricula for the subject of History at school, the construction of history textbooks, the teachers' contribution in the construction of the past, comparative research on history teaching, investigation of the possibilities to rationalize historical discourse at school
